# Spatial Analysis of Obesity: GIS and Descriptive Epidemiology

### Summary

GIS, the abbreviation for geographic information systems, is a collection of science and technology tools used to manage geographic associations and integrate information. GIS helps analyze spatially referenced data and make well-informed decisions about the basis of the association between data and geography. GIS refers to both the software and hardware that create the system of digital databases and layered maps. However, it is more than that; GIS is used for making decisions. At the Centers for Disease Control and Prevention (CDC), GIS plays an important part in health promotion and protection.

For example, CDC's Division for Heart Disease and Stroke Prevention has an interactive atlas that is based on GIS data (Figure 1). This application allows users to view county-level maps of heart disease and stroke, along with maps of social environmental conditions and health services for the entire United States or for a chosen state or territory. Congressional boundaries and health care facilities can be added with an overlay. The map in Figure 1 displays heart disease death rates/100,000 persons aged  $\geq$ 35 years by Georgia county, during 2008–2010. This information can be used for health promotion activities (e.g., tobacco, and obesity prevention programs) in the counties that are most in need.

In this lesson, students use the geographic inquiry process to explore potential associations among obesity, income, and physical activity in Georgia. Students use ArcGIS Online, to layer and analyze data to observe potential patterns. Students explore the role of epidemiologists in asking questions and testing hypotheses to determine the associations among variables. The concepts and activities are appropriate for students in grades 6–8, but can be used with older students.

An important note: Teachers are able to request free access to ArcGIS Online through Esri as part of the ConnectED Initiative prior to using this lesson plan: http://www.esri.com/connected. In June 2013, President Obama announced the ConnectED initiative, designed to enrich K-12 education for every student in America (https://www.whitehouse.gov/issues/education/k-12/connected). Esri partnered with the Association of American Geographers to provide free access to ArcGIS Online accounts to every K-12 school in the U.S. through the ConnectED initiative as well as training resources and a mentor program (http://geomentors.net/) to support teachers and students.

Teachers may also sign up for an ArcGIS Public Account at https://www.arcgis.com/home/signin.html, which is a personal account with limited usage and capabilities and is meant for non-commercial use. A public account provides enough capability to complete this lesson plan.

# **Learning Outcomes**

After completing this lesson, students should able to

- use GIS as a model to overlay data regarding obesity rates, income, and physical activity in the state of Georgia to identify patterns;
- analyze patterns in data to develop questions and generate hypotheses between obesity and variables that affect obesity in Georgia, specifically income and physical activity; and
- explain epidemiologists' role in descriptive epidemiology by asking who, what, and where questions, and testing hypotheses to determine causes of disease among a population.

### **Duration**

This lesson can be conducted as one-, 135-minute lesson, or divided into three-, 45-minute lessons.

### **Procedures**

# Day 1: Introduction to the Geographic Inquiry Process (45 minutes) Preparation

Before Day 1,

- Ensure access to ArcGIS online. Teachers are able to request free access to ArcGIS Online through Esri as part of the ConnectED Initiative: http://www.esri.com/connected.
- Post pictures at regular intervals around the room for a gallery-walk activity. See introduction activity for more details.

### **Materials**

- Computers and Internet access to ArcGIS for each pair of 2 students.
- Select 5–10 pictures for gallery-walk activity. Pictures should be of different scenes (e.g., roads, trains, homes, people exercising) and can be from different sources, including online or from magazines and newspapers.

Description: Students will think about what is in each picture and how they could measure different aspects (e.g., length of a road, how people exercise, how tall something) to prompt a discussion about the different way something could be measured and the potential problems if things are measured different. This will lead into a discussion about the concept of BMI as one way to standardize measuring someone's body mass.

- Defining Obesity Materials Description: Obtain information about obesity and how it is defined, including medical complications of obesity and related costs. Suggested website: http://www.cdc.gov/obesity/adult/defining.html

- Worksheet 1: Displaying Obesity Data in ArcGIS Online (Appendix 1A). Description: A set of instructions to follow as students add data to ArcGIS online.
- Worksheet 2: Applying the Geographic Inquiry Process graphic organizer (Appendix 2A). Description: A visual representation of the geographic inquiry process that students will complete as they explore each stage of the process

### **Online Resources**

  - Description: ArcGIS is a collaborative, cloud-based platform that allows students to use, create, and share maps, web applications, and data, including authoritative basemaps. Students will overlay data related to obesity in Georgia in a GIS to determine associations among the data. If requesting free access to ArcGIS Online through Esri as part of the ConnectED Initiative, please follow directions provided with the account.

### Activity

- 1. Begin the lesson with a picture-gallery walk. Divide students into groups and tell them to start at a picture and as a pair, study the photos of different scenes (e.g., roads, trails, homes, people exercising) and think about what is in each picture and how they could measure different aspects (e.g., length of a road, how people exercise, how tall something is). After 1 minute, have groups rotate to the next picture. Continue the rotation until all groups have seen all of the pictures.
- 2. Prompt a discussion about measurement. Have students share the different ways something could be measured. Discuss how many different ideas are generated. Then, ask students to think about the potential problems if things are measured differently. Have students discuss how they would make sure everyone is measuring in a similar way.
- 3. Discuss the definition of *obese* for adults and the lesson plan objectives. Introduce concept of BMI as one way to standardize measuring someone's body fatness. Explain to students that obesity is measured using BMI. Emphasize the importance of body mass index in the definition.
- 4. Discuss the medical complications and the costs associated with obesity. Prompt a discussion about potential health effects of obesity and how they might be measured. Have students generate ideas about what factors could impact obesity (e.g., environment, food choices, genetics, activity levels, location) and how they could be measured.
- 5. Focus on location as a factor that could impact Obesity. Ask students, "What are the obesity levels in the United States and how does it differ by location (e.g., state, county, region)?" Tell students that this is an example of a geographic question. Geographic questions are about spatial associations in the world. Explain that the geographic inquiry process is the method used to answer geographic questions.
- 6. Project an image of the geographic inquiry process and review the steps of the geographic inquiry process. Tell students they will be following this process to answer the question "In what areas of Georgia are persons the most obese?" Explain that they have completed the first step of the process by asking the question. Explain that today they will be using GIS to complete Step 2, acquiring geographic resources.
- 7. Introduce ArcGIS Online and explain how to open the program, display a map of the United States, and search for obesity data.
- 8. Direct students to select a partner and sit in front of a computer. Distribute Worksheet 1: Displaying Obesity Data in ArcGIS Online (Appendix 1A), and have students work in pairs at their computers to produce their own maps by following worksheet directions.
- 9. Distribute Worksheet 2: Applying the Geographic Inquiry Process graphic organizer (Appendix 2A), and have students complete the first 2 steps of the geographic inquiry process by describing what they did.
- 10. Review Steps 1 and 2 on the graphic organizer with the class.

### Day 2: Exploring Geographic Data (45 minutes)

### Preparation

Before Day 2,

• Make copies of Activity 1: Geographic Inquiry Process Sort (Appendix 3A). Cut out the statements at the top. Place the statements in an envelope. Create 1 envelope for each pair of students.

### **Materials**

- Activity 1: Geographic Inquiry Process Sort (Appendix 3A), 1 copy per student. Description: Statements that describe each step of the geographic inquiry process, and an answer key that includes the correct placement of the statements in the geographic inquiry process.
- Worksheet 3: Steps for Exploring Obesity Rates in Georgia (Appendix 4A), 1 copy per student. Description: A set of instructions to follow as students explore obesity, income, and physical activity data across Georgia by using ArcGIS online. An answer key is available (Appendix 4B). Please note that in this activity students are asked to compare 2007 obesity data with 2012 income and physical inactivity data. Comparing data across years has several limitations. As you guide students through this activity, consider addressing this as a class and discuss how those limitations could affect their analysis in this activity.
- Worksheet 4: Exit Ticket (Appendix 5), 1 copy per student. Description: A closing activity to summarize student learning and interest inventory.
- Computer and Internet access for each pair of 2 students.

### **Online Resources**

Students will overlay data related to obesity in Georgia in a GIS to determine associations among the data.

### Activity

- 1. Review the steps of the geographic inquiry process by having students do a sort activity. Place students in pairs of 2 and distribute an envelope containing a set of statements from Activity 1: Geographic Inquiry Process and match the sort activity (Appendix 3A) with each pair. Instruct students to match the steps of the geographic inquiry process with each statement describing the process by using their desktops as a working surface. Give students time to sort and match the statements with the correct step, then review placement of the statements with the entire class.
- 2. Tell students to locate their partner from Day 1 and sit in front of a computer. Briefly, review how to access ArcGIS and retrieve their maps. Tell students they will complete adding income and physical inactivity data to their GIS. Explain to students that they are working with physical inactivity data (e.g., time watching television or on the computer). Note that high physical inactivity data are not the same as low-physical activity and cannot be assumed.
- 3. Ask students to complete Step 3 of the geographic inquiry process, exploring geographic data as they add more data to their maps. Distribute Worksheet 3: Steps for Exploring Obesity Rates in Georgia (Appendix 4A), 1 copy per student. Give students time to follow the steps to overlay income and physical activity data on their maps and follow the instructions for overlaying and digitizing areas of interest about their data. Direct students to save their maps after analysis completion.
- 4. Distribute Worksheet 4: Exit Ticket (Appendix 5), 1 copy per student, and have students turn in the assignment before they leave class.

# Day 3: Analyzing Data to Guide Further Inquiry (45 minutes)

### Materials

- Worksheet 5: Scavenger Hunt (Appendix 6A). Description: A self-paced guide for students to search and collect information about epidemiologists from Science Buddies website.
- Teacher Handout: Assumption Buster (Appendix 7). Description: A copy of the data that dispel certain assumptions that students might have about the associations between obesity and income.
- Assessment 1: Summative Assessment (Appendix 8A). Description: An assessment of what the students have learned throughout the lesson.

   Description: Data are not always what they appear. Obesity is based on multiple factors and caution is needed before drawing conclusions without the entire data set. In the assumption-buster activity, students will read the journal article and compare findings with the GIS activity.

# Activity

- 1. Direct students to Worksheet 2: Applying the geographic inquiry process graphic organizer (Appendix 4A) and review Steps 3 and 4 of the geographic inquiry process they completed with ArcGIS on Day 2. Ask students about the associations they discovered among obesity, income, and physical activity. (The majority of students should respond that they determined that obesity is high in areas where income and physical inactivity is high.)
- 2. Review Step 5 of the geographic inquiry process by telling students that they have used GIS to integrate data from multiple sources and to assemble information into knowledge that enables them to act. Explain that epidemiologists are scientists who follow a similar inquiry method to answer questions by determining associations involving a medical condition and such factors as human behavior, other diseases, and geographic location.
- 3. Explain to students that epidemiologists do not make assumptions about individual behavior from data on the basis of populations (e.g., what they gathered about obesity). Epidemiologists use the inquiry process to identify and establish associations that are supported by data.
- 4. Tell the students they probably have made certain assumptions about obesity-related factors. Emphasize that they would have to do much more investigating and data collection before they could say with any certainty whether associations among the data are causal or not.
- 5. Project Teacher Handout: Assumption Buster (Appendix 7) for the class to view additional obesity data collected by epidemiologists. The data indicate that the majority of obese persons are not among low-income persons. Emphasize that these data might have dispelled assumptions they had made about obesity and income.
- 6. Distribute Worksheet 5: Scavenger Hunt (Appendix 6A). Explain that students, with their partner, will perform a scavenger hunt to locate additional information about epidemiologists..
- 7. Distribute Assessment 1: Summative Assessment (Appendix 8A) and have students complete it before leaving class.

# Conclusion

Students will use the geographic inquiry process to explore potential relationships among obesity, income, and physical inactivity in the state of Georgia. Students will use ArcGIS, a geographic information system (GIS), to layer data and analyze data to observe potential patterns. Students will explore the role of epidemiologists in asking questions and testing hypotheses to determine the relationship between variables. Then, students will identify public health promotion strategies based on the information collected.

# Assessments

- Worksheet 3: Steps for Exploring Obesity Rates in Georgia (Appendix 4A), 1 copy per student. Learning Outcome(s) Assessed:
  - use GIS as a model to overlay data regarding obesity rates, income, and physical activity in the state of Georgia to identify patterns;
  - analyze patterns in data to develop questions and generate hypotheses between obesity and variables that affect obesity in Georgia, specifically income and physical activity; and Description: Students explore obesity, income, and physical activity data across Georgia by using ArcGIS online. Then, they analyze patterns to develop hypotheses about physical activity, income, and obesity.
- Worksheet 5: Scavenger Hunt (Appendix 6A). Learning Outcome(s) Assessed:
  - explain epidemiologists' role in descriptive epidemiology by asking who, what, and where questions, and testing hypotheses to determine causes of disease among a population. Description: Students research information about epidemiologists and the role they play in public health.
- Assessment 1: Summative Assessment (Appendix 8A). Learning Outcome(s) Assessed:
  - use GIS as a model to overlay data regarding obesity rates, income, and physical activity in the state of Georgia to identify patterns;
  - analyze patterns in data to develop questions and generate hypotheses between obesity and variables that affect obesity in Georgia, specifically income and physical activity; and
  - explain epidemiologists' role in descriptive epidemiology by asking who, what, and where questions, and testing hypotheses to determine causes of disease among a population.

Description: An assessment of what the students have learned throughout the lesson.

# Appendix 1A: Worksheet 1: Displaying Obesity Data in ArcGIS Online

# **Displaying Obesity Data**

### Sign In

- 1. Access ArcGIS Online (available at: http://www.arcgis.com/home/).
- 2. Click *Sign In* button (top right). You will need to log in to your class' Esri account. Your teacher will provide you with this information. Type the username and password that your teacher gives you exactly as written. Note: Username and passwords are case-sensitive!

### Find a Location

- 3. Choose *Map* option.
- 4. Find Atlanta by entering *Atlanta* in the search bar (top right). This is the *Find* Window. You have now zoomed in on Atlanta, Georgia, in the United States.

Change the Basemap

- 5. A *basemap* is a noneditable layer that provides background (reference information) in your map. It is typically designed to provide a visual reference to help orient the map user. Click the *Basemap* button.
- 6. Select the different basemaps, and list the 12 different basemaps you can choose.

Move around the Map

- 7. Move around the map by panning (i.e., clicking and dragging) the map.
- 8. Zoom in to view greater detail of the Atlanta area. Try zooming in to a location by holding down the Shift key, left clicking your mouse, and dragging a box.
- 9. Type United States into the search bar.

#### Add Data to the Map

- 10. Click Add button in the toolbar.
- 11. In the drop-down menu, click Search for Layers.
- 12. Type obesity in the Find function. Leave the In function as ArcGIS Online. Click Go.
- 13. Find the layer that is titled *USA\_Obesity\_Rates* by Esri Training Service. Click *Add*. Note: This thematic map presents the adult obesity rate in the United States in 2007 [Behavioral Risk Factor Surveillance System (BRFSS), 2007]. In this map, overweight and obesity are both
  - labels for ranges of weight that are greater than what is generally considered healthy for a given height. Please also note that more recent data are available at:

http://nccd.cdc.gov/NPAO\_DTM/IndicatorSummary.aspx?category=28&indicator=29.

- 14. Click Done Adding Layers (bottom left).
- 15. Click Map Legend button below in the toolbar.

Start to Analyze the Data

- 16. Circle the correct answer for what the darker color means in the legend.
  - a. lower rate of obesityb. higher rate of obesity
- 17. Identify the 8 states that had the highest rates of obesity in 2007. Hint: Make sure to zoom out so that you can see Hawaii and Alaska in your map viewer.
- 18. Identify the 5 states that had the lowest rates of obesity in 2007.

Save Your Map

19. Click *Save*. You will have to give your map a title (team name is preferable), a tag, and a brief summary of your map to save it. Click *Save Map*.

If yes, what are they?Answer: Overlap occurs in 2 areas (the mideast and southwest). These data might indicate that an association exists between income and obesity.

- 1. What do epidemiologists do? **Answer:** Epidemiologists are medical scientists who investigate and describe factors that influence the development of disease, disability, and other health outcomes. They formulate means for prevention and control.

An epidemiologist might analyze what types of diets are most effective at preventing heart disease, analyze data to determine what factors influence the development of a disease (e.g., diabetes), or travel to the Democratic Republic of the Congo to help monitor and contain an outbreak of the deadly Ebola virus.
- 3. What education do epidemiologists need? Answer: To become an epidemiologist, you must have at least a master's degree from a school of public health. In certain cases, you might need a PhD or a medical degree, depending on the work you will do. Clinical epidemiologists or research epidemiologists who work in hospitals and health care centers often must have a medical degree with specific training in infectious diseases. You will need to be a licensed physician (having passed a licensing examination) if you are going to administer drugs in clinical trials. Epidemiologists who are not licensed physicians frequently work closely with persons who are licensed.
- 4. What other qualifications do epidemiologists need? Answer: Epidemiologists should be able to work independently or as part of a team and be able to communicate clearly and concisely, both orally and in writing. Epidemiologists in private industry, especially persons who aspire to consulting and administrative positions, should possess strong communication skills so that they can provide instruction and advice to physicians and other health care professionals.
- 5. List crucial requirements that epidemiologists need to be successful in their career. **Answer:** Meticulous, analytical, logical, sensitive to other cultures, able to work independently or in groups, along with excellent communication skills and a strong desire to help people.

Research epidemiologists conduct studies to determine how to eradicate or control infectious diseases. For example, they often focus on research to determine the incidence of a particular disease in a particular part of the world. They might study different diseases (e.g., tuberculosis, influenza, or cholera) and often focus on epidemics. Research epidemiologists work at colleges and universities, schools of public health, medical schools, and research and development services firms.

Clinical epidemiologists mainly work as consultants in hospitals, informing medical staff of infectious outbreaks and providing ways to control the spread of infection. In addition, clinical epidemiologists are usually the persons who develop a hospital's standards and guidelines for the treatment and control of infectious diseases.

Key findings

- Among men, obesity prevalence is similar at all income levels; however, among non-Hispanic black and Mexican-American men, persons with higher income are more likely to be obese than persons with low income.
- Women with a higher income are less likely to be obese than women with a low income, but the majority of women who are obese not among low-income earners.
- No substantial association between obesity and education among men has been reported. However, among women, an association has been reported. Women with a college degree are less likely to be obese, compared with less-educated women.
- The prevalence of obesity increased among adults at all income and education levels during 1988–1994 and 2007–2008.

Answer: For adults, overweight and obesity ranges are determined by using weight and height to calculate a number known as the body mass index (BMI). BMI is used for the majority of persons because it correlates with their amount of body fat. An adult who has a BMI of 25–29.9 is considered overweight. An adult who has a BMI  $\geq$ 30 is considered obese.

- List the 5 steps of the geographic inquiry process.
   Answer: (1) Ask a geographic question; (2) acquire geographic resources; (3) explore geographic data; (4) analyze geographic information; and (5) act on geographic knowledge.
- 3. Explain how you have applied each step of the geographic inquiry process during the past days. **Answer:** Answers will vary, but should identify their work with ArcGIS.
- 4. Briefly explain how someone would add data to ArcGIS Online. Answer: Click the *Add* button in the toolbar. In the drop down menu, click *Search for Layers*. Answer: GIS is an exploratory science because of the following reasons: (1) ask a question about location-based associations in the world around you; (2) acquire geographic resources by identifying data and information that you need to answer your question; (3) explore data by turning the data into maps, tables, and graphs, and look for patterns and associations; (4) analyze geographic information by determining what the patterns and associations might mean with respect to your question; and (5) act on geographic knowledge by using the results of your work to educate, make a decision, or solve a problem. In epidemiology, you also identify patterns and make group comparisons. In epidemiology, unlike GIS, you can identify association and judge causation through research and clinical epidemiology. The ability to draw conclusions about association and causation in epidemiology make it a confirmatory science, whereas in GIS, you cannot draw such conclusions leaving it solely an exploratory science.
